# THE PROGRESS OF THE ORGANIZATION INSTITUTIONAL DEVELOPMENT

### In 2015 the Organization received an updated CHARTER corresponding the STRATEGY and the directions of development. The key changes are:

•

Creation and work of the Supervisory Council (former Board of Directors) as a new collective managing body of the Organization.

•

Governance and management are clearly differentiated; the staff of the Organization is removed from the Supervisory Council.

#### THE MAIN RESULTS OF WORK OF THE SUPERVISORY COUNCIL

According to the provisions of the new version of the Charter the Board of the Directors was cancelled and the Executive Director of the organization was elected.

The list of members of staff, elaborated taking into account the cancellation of the Board of Directors and the needs of the providing the Organization with the human resources, was approved.

The Regulation on the Executive body of the Organization, the project of which was preliminary agreed with all members of the Supervisory Council, was approved.

The position instruction of the Executive Director was approved.

#### THE SPHERE OF MANAGEMENT, MAIN RESULTS

The mechanism of the evaluation of the staff is elaborated, based on the results of the monitoring of the activity of new employees since they start working for the Organization.

The procedure of evaluation and analysis of the effectiveness of the mechanism of decision-making and decision-implementing is elaborated.

The manual on the project management and the manual on the organization management are elaborated.

### THE NEW ACHIEVEMENTS IN NETWORKING

In November 2015 the Organization was elected as the leader of the International coalition "For Visa-Free Europe" which unites more than 40 organizations from whole Europe.

"Europe Without Barriers" joined the Think Tanks Liaison Office in Brussels and is one of its founders. The NGO held the round table and working meetings in the European Parliament and European Commission together with the Office.

The representatives of the Organization became a part of the leadership of the Ukrainian National Platform of the Eastern Partnership Forum and the Organizing Committee of the Annual Assembly of the Eastern Partnership Civil Society Forum which has took place on 19-21 November 2015 in Kyiv.
